A revised timeline to merger is presented below. The following considerations have to be noted:

- COVID-19 restrictions has had significant implications for the parliamentary process and the full effect on timelines and legislative process is not yet clear;
- The implications of Brexit on the legislative process are unknown;
- Parliamentary recess dates have not been set for 2021 and are therefore assumed based on this year; and
- The date of the Scottish Parliamentary Election has not been set. The assumption is that this will happen around w/c 3rd May 2021. This would assume that the dissolution of the Scottish parliament is likely to happen around 26 March 2021.
