Executive Summary

This paper is designed to reflect the process that Search and Nominations Committee undertook in its considerations for recommendations to Board of Management with regards to committee assignations, and in particular to redress the imbalances amongst committees.

Shetland UHI has the following committees that support the work of its Board of Management:

- Finance and General Purposes Committee
- Learning, Teaching and Research Committee
- Human Resources and Remuneration Committee
- Search and Nominations Committee
- Audit Committee

Shetland UHI's committee membership is unbalanced with three committees currently holding 7 members, one holding 5 members, and one holding 1 member. The questions that Search and Nominations Committee produced answers for, in the form of recommendations to the Board of Management, are:

- 1. Who should serve as Chair of Audit Committee?
- 2. Which committee, if any, should be the Chair of Human Resources and Remuneration Committee have as their third committee assignation?
- 3. What should the Committee Assignations be for Staff Directors?
- 4. How could each Independent Director be given committee assignations to either:
 - a. Finance and General Purposes Committee, or
 - b. Audit Committee
- 5. How could each Independent Director be given committee assignations to either:
 - a. Learning, Teaching, and Research Committee, or
 - b. Human Resources and Remuneration Committee, or
 - c. Search and Nominations Committee

Search and Nominations Committee also answered the question: Which committee, if any, should be the Chair of Finance and General Purposes Committee have as their third committee assignation, however, after the meeting, it was discovered that the terms of reference of Human Resources and Remuneration Committee, prescribes the role to sit on said committee.

Search and Nominations Committee recommended that Lauren Doughton serve as Chair of Audit Committee, and no third assignation should be given to the Chair of Human Resources and Remuneration Committee at this time.

The results of all committee assignations can be found in the table below, with the colours indicating the following:

- Dark blue signifies ex-officio member
- Light blue signifies prescribed member
- Yellow signifies Committee Chair
- Orange signifies membership retention
- Dark red signifies committee resignation

Since Search and Nominations Committee made their recommendations, Cally Mair has resigned. As her committee assignations are prescribed in her capacity as HISA Shetland Depute President, they will be taken up by Ian McCormack, her successor who's term starts on 1st July 2022.

The Regional Student Director (currently vacant) is a prescribed member of Learning, Teaching, and Research Committee. The post-holder cannot be assigned to Audit Committee.

Considerations undertaken by Search and Nominations Committee during their process of establishing recommendations for committee assignation to Board of Management

Chairs

Prior to their meeting in March, all current Committee Chairs were asked whether they wished to retain their positions. All Committee chairs requested the retention of the current committees that they chair, and therefore Search and Nominations Committee did not consider alternative committee assignments for these individuals. Previously, Karen Hall was also assigned to Audit Committee, giving her four committee assignments. As this exceeded the number of committee assignments of all other committee chairs, and all other directors except the Principal, Karen agreed to step down from Audit Committee.

Supplementary Questions

Search and Nominations Committee were asked a variety of supplementary questions to help Search and Nominations Committee draw conclusions to the main questions that formed their recommendations to Board of Management. These supplementary questions fell under the following headings:

- Quoracy
- Chair of Audit Committee
- Third Committee Assignment for Chair of Human Resources and Remuneration Committee
- Committee Assignments for Staff Directors
- Committee Assignments of Independent Directors to either Finance and General Purposes
 Committee, or Audit Committee
- Committee Assignments of Independent Directors to either Learning, Teaching, and Research Committee, or Human Resources and Remuneration Committee, or Search and Nominations Committee

Summary of Committee Assignation prior to recommendations

Search and Nominations Committee was presented with a summary of the variety of membership stipulations across all committees, via the table below, noting that, some roles serve in an ex-officio capacity, some roles being prescribed or required by the terms of reference, and other roles being open to serve on any committee. The committee composition is demonstrated in the table below, with dark blue indicating ex-officio roles, lighter blue indicating required roles, yellow indicating chairs, and red indicating excluded roles. The numbers in brackets demonstrate the impact of fulfilling of two of the three vacant roles, namely, Chair of Audit Committee, and Regional Student Director. By law the board may recruit up to one additional Independent Director.
