## Introduction

Throughout the academic year we are subject to a variety of external audits linked to our learning and teaching provision. A report of this activity is provided here for the information of the Learning, Teaching and Research sub-committee. This information is also included in a regular wider report on audits to our audit committee.

The external verification (EV) visits for specific courses undertaken by SQA are very detailed and for 10 of the 11 completed so far have been positive with no actions identified and a number having good practice commended. There are further EV 'visits' planned and in prospect. As has previously been reported we are due to have an SQA systems verification audit in the coming period.

Professional body accreditation involves different patterns of inspection/audit depending on the body involved. This year so far we have had two such reviews, both were positive.

The Further Education Statistics audit (FES audit) is an annual activity to review the accuracy of our record keeping. There were a number of findings this year which we plan to address as we develop our registry.

SDS regularly reviews our compliance with their procedures with regard to the Modern Apprenticeship contract. Minor findings from the most recent visit have been addressed.

Education Scotland is in touch with us throughout the year and there is an annual engagement. The visit this year was positive and feedback will be given to our next board meeting. They are focussed on our FE provision.

QAA (Quality Assurance Agency for higher education) is the authority reviewing HE provision – this is usually on a five year cycle and is carried for UHI – our involvement is guided by that programme of activity.

REF (Research Excellence Framework) reviews research activity across all universities on a 5-7 year cycle and is also a UHI exercise. We have just completed a REF cycle and the next one is likely to be in 2027 with requirements being consulted on in the coming few months.
